ADMISSION NOTICE (2023-24/25)

In pursuance to the Director Skill Development, J&K, Srinagar's Admission Notification No: **DSD/401/Trgs/2023/725-818 Dated: 01.06.2022**, online applications are invited from the desirous candidates for seeking admission in the Government Industrial Training Institute, R. S. Pura for the academic session **2023-24/25**. The desirous candidates having minimum age of **14 years** (as on 01.06.2023) with no upper age bar can apply for admission in various Engineering/Non-Engineering Trades having duration of one Year & two Years under Normal/Self-Financing schemes as per their eligibility from **1st of June 2023 onwards**.

The desirous candidates have to fill up the admission forms online available at ITI Admissions Portal link: (<http://itiadmissions.jkdsd.in>) and also present on the official website of Directorate of Skill Development J&K i.e. www.jkdsd.in. The last date for applying online is up to **21.06.2023** (extensions, if any, will be notified separately).

The details pertaining to trades functioning in Govt. ITI R.S.Pura for which admissions are to be made for the session 2023-24/25 under Normal and Self Financing Schemes are available on the Portal link: (<http://itiadmissions.jkdsd.in>).

Applicants have to fill up complete details which include Personal Details like: Name, Parentage, Qualification Details etc. (including marks obtained) online on the portal, besides necessary uploading of following documents in **jpg** format having size between **20 KB to 200 KB**.

1. Marks Certificate of qualifying examinations: both 8th and 10th
2. Date of Birth Certificate
3. Category Certificate (ST/SC/ Ex. Serviceman/ Physically Handicapped/ EWS) if any
4. Aadhar Card

****Domicile Certificate will be mandatory at the time of admission in ITI R S Pura*.***

The process of filing of admission forms will be in four stages:-

1st Stage (at ITI R S Pura): The applicants can attend counseling cell in ITI R S Pura for making up their mind for selection of trade/s (**optional**).

2nd Stage (online): The candidate will log in to the portal (<http://itiadmissions.jkdsd.in>) and finalize his/her profile complete with Personal and Academic Details including uploading of all documents.

3rd Stage (online): The candidate will finalize his/her application after carefully selecting the trade priorities (remember candidate once selected for his/her priority no: 1 will not be offered any second option). Candidate will then take print out (hard copy) of the system generated application and submit the same at Govt. ITI R.S.Pura.

4th Stage (at ITI R S Pura): The candidate will deposit the application form along with the form-fee and self-attested photocopies of the uploaded documents. On receipt of the form, the office will verify and finalize the application online. Form fee @ **Rs 100/-** per three trades will be deposited by the candidates.

important Notes:-

1. Detailed guidelines for filing of application form are also available on the admission portal (<http://itiadmission.jkdsd.in>), in case of any technical issue kindly mail on help me (iticell.jkdsd@gmail.com).
2. Selections will be carried out on the basis of Merit, up-to the intake capacity of the trade.
3. Selection lists/ Waiting Lists will be duly notified for the information of public.
4. Separate notification shall be issued to fill up the vacant seats, if any, in due course of time.
5. Candidates, who have already undergone training in any of the trades of ITIs, can apply for admission in another trade after completion of two years of previous training course. However, for the ensuing academic session their admission is considered in any of the trades having poor response.
6. Admission fee is required to be deposited by the selected candidates on the date of admission itself, without delay.
7. A duly attested affidavit shall be required to be submitted on admission, stating that the candidate is not pursuing any job/training/education and will abide by all rules and regulations set by the institution.
8. Candidate should provide unique mobile number and e-mail address and to maintain it till completion of course and receive the certificate, as change is not permitted later.
