### **ADMISSION NOTIFICATION SESSION 2025-26-27**

In pursuance to Directorate of Skill Development Jammu/Srinagar's Admission Notice under endorsement No. DSD/401/Trgs/2025/1521-1611 Dated: 08-05-2025, online Applications are thus invited from desirous candidates for seeking admission in Govt. ITI R.S.Pura for the academic Session 2025-26-27 to various Engineering/Non Engineering trades having duration of two years/one year for free &Self Finance seats being run under NCVT/SCVT schemes and commencing from 15<sup>th</sup> May, 2025 for which the forms can be uploaded till 15<sup>th</sup> May 2025.

The desirous candidates having minimum age of **14** years as on 1st September 2025 with no upper age bar have to fill the admission forms available online at ITI admission portal (<a href="https://itiadmissions.jkdsd.in">https://itiadmissions.jkdsd.in</a>) link is also present on the official website of Directorate of Skill Development, J&K i.e. www.jkdsd.in.

The last date of applying online is upto 30<sup>th</sup> of May 2025. The candidates have to fill up the complete details which include basic details like name, parentage, qualification etc. online in the portal and have to upload the following documents on the portal:-

- 1. Marks Certificate of Qualifying Examination.
- 2. Date of birth Certificate.
- 3. Category Certificate (SC, ST, Ex- serviceman/ Physical Handicapped/EWS) if any
- 4. Aadhar Card.
- 5. Domicile certificate should be produced at the time of admission in ITI.

The candidates after finalizing the profile and application online will be required to deposit the printout of the system generated application completed in all respect along with self-attested documents uploaded on the portal and deposit the prescribed fee of Rs. 100/- (Rupees hundred only) per three trades against the proper Fee receipt in **Govt. ITI R.S.Pura**.

## The process of filing of admission forms will be in Three stages:-

I<sup>st</sup> Stage (In ITI R.S.Pura): Before applying the online form the applicants can attend counseling cell in ITI R.S.Pura for making up their mind for selection of trade/s.

2<sup>nd</sup>Stage(online): The candidate will login to the portal (https://itiadmissions.jkdsd.in) and finalize his/her profile complete with Personal and Academic Details including uploading of all documents. Then candidate will finalize his/her application after carefully selecting the trade priorities. Candidate will then take print out (hard copy) of the system generated application and submit the same at Govt. ITI R.S.Pura.

3<sup>rd</sup> Stage (in ITI R.S.Pura): The candidate will deposit the application form along with the form-fee and self-attested photocopies of the uploaded documents. On receipt of the form, the office will verify and finalize the application online. Form fee @ Rs 100/per three trades will be deposited by the candidate.



### Important Note: -

- 1. The applying candidate has to submit printout of system generated application along with requisite self- attested documents at Govt. ITI R.S.Pura.
- 2. The candidate shall deposit the fee @100/- (Hundred only) per three trades at Govt. ITI R.S.Pura against a proper receipt.
- 3. Selection will be made purely on the basis of academic merit obtained by the applicant in their qualifying examination (both for free and self financing seats separately).
- 4. On successful completion of training in trades affiliated under NCVT/SCVT scheme. Certificate will be awarded by the National/State council for Vocational training.
- 5. Candidates who have already undergone training in any of the trades in any ITI can apply for admission in another trade after two years of completion of previous training course. However, for the ensuing academic session their admission can be considered in any of the trades having poor response.
- 6. Selected Candidates should retain a consistent mobile number and e-mail address, till completion of course, until certification, as changes are not permitted by DGT.
